FOREWORD

Dear ICSOBA Members,

At the time of printing this foreword, we are only four months ahead of our next international conference which will be held in the Grand Mercure Hotel in Belem (Brazil) from 29th of October to 1st of November. The program organizers already received many abstracts and I encourage those of you who didn't to lodge yours before the June deadline. As you understand, complying with abstract and full paper deadlines is paramount to ensure quality review by the Technical Committee. However, as a tradition with ICSOBA, we will make our best efforts to integrate late abstracts.

Since the Hamburg conference landscape our aluminium witnessed many events from sustained higher LME price associated with China production control, imposition of US import tariffs, still unsettled, decision of US sanctions directly impacting RUSAL consequently, and, disturbing aluminium, alumina and bauxite markets and, very recently, the announcement of a breakthrough smelting technology development by Alcoa / Rio Tinto.

Alongside those events and announcements, Industry 4.0 concept is making progress and we can observe many signals of significant evolution of aluminium industry with this respect.

This year ICSOBA is returning to Brazil, a country with a long history of aluminium industries, and it will be the perfect forum to learn and debate those issues. Venue of the conference

- Alunorte alumina refinery
- Paragominas bauxite mine

The allowed number of visitors is limited (45, 40, 30, respectively).

The trip to Paragominas is long and requires a one-night stop at a local hotel (included in the price). The bus to Paragominas will leave Grand Mercure at 8:00. Arrival is planned for 13:30 with a 0.5 h stop on the road. A stay overnight at a hotel is necessary but its cost is included in the price. Meals are at the delegate expense. Return from Paragominas to Belem is expected at 13:00 on Friday, 2 November.

The bus to Albras in Barcarena will leave at 9:00 with 11:00 arrival time. The return departure is planned at 15:00 the latest. Busses will be properly identified with ICSOBA logo. Please reserve your seat on the bus early.

For the plant visits each visitor must provide information regarding the size of shoes and t-shirts during ConfTool registration. This information will be

transmitted in advance to the plant. Each plant will then provide the necessary PPEs. All visitors must wear long trousers (jeans), long-sleeved shirt and closed shoes without heels (sneakers).

Plant will provide a driver to escort the vehicle of the visitors inside the units.

ICSOBA Financial Situation

ICSOBA fiscal year with Revenue Quebec and Revenue Canada is from 1 January to 31 December. Management of ICSOBA is responsible for the preparation of these financial statements in accordance with Canadian accounting standards for not-for-profit organizations. Continuing our dedication to transparency ICSOBA finances are audited. Since 2013 a public accountants' office of Gariépy & Bussière CPA INC is requested to carry out the annual task.

Summary of operations revenues and expenses (in CAD\$) for years ending 31 December 2017, 2016, 2015 and 2014 is as follows:

In the 2017 financial statements of the auditors we read: "Based on the review, nothing indicates that the 2017 Financial Statements are not in accordance with Canadian accounting standards for not-for-profit organization".

As the financial statements reveal the excess of revenues over expenses was \$62,140 last year, compared to losses in some of the previous years (2013, 2014). This was chiefly possible due to better than expected delegates participation from Germany and from Europe. Also, no services were hired to do local organization tasks as all contributions came from ICSOBA and TRIMET staff. The support from sponsors and exhibitors (\$80,100) was almost the same as in 2016.

Following the financial review, the tax declarations were filed with Revenue Quebec and Revenue Canada for 2017. Confirmations have already been obtained that ICSOBA does not have taxes to pay and retains its not-for-profit status.

ICSOBA primary revenue leaders are the events and sponsors. We would like to take this opportunity to thank sponsors and exhibitors for your invaluable support. It is such a privilege to be able to count on a strong



and devoted community. Your support makes a real difference. As a not-for-profit, ICSOBA focuses on using all resources to advance the association's mission. The available funds belong to the association and are meant for the development and promotion of ICSOBA and future events. Some money reserve is necessary for rainy days and to continue uninterrupted operations and monetary advances. Present ICSOBA monetary reserve should help to ensure continuity of ICSOBA.

It is fair to acknowledge that it is not possible to have ICSOBA management working very hard and very long hours without some compensation. Also, several volunteers provide significant amounts of time to the activities of the organization. Because of the difficulty in assigning values for such services, the value of donated time is not reflected in the financial statement. At the same time, we admit that any compensation needs to be transparent.

Some changes to compensations of ICSOBA management and organizing staff were proposed. For example, the Board of Directors has resolved to wave the conference registration fee to assist active organizers and help them participate in the events. Details will be presented at the Annual Meeting of Members in Belem.

Election to the Board of Directors

The most important responsibility that we all have toward the association is to assure ICSOBA continuity and growth. ICSOBA is an international association of members and the members periodically elect the Board of Directors in the Annual Meeting. The next election will take place at the time of the 36th ICSOBA conference to be held in Belem, Brazil (on 31 October in the evening). Among the existing Board members Frank Feret, Andrey Panov and Michel Reverdy have been elected at the last election in Zhengzhou, China for 2 + 2 years. Their four years of the mandate will come to the end at the time of the conference in Belem. Four other directors on the present Board (Claude Vanvoren, Matthieu Arlettaz, Houshang Alamdari and BS Pani) were elected in Quebec in 2016. The 2019 President will be nominated according to current Bylaws.

During the election we need to make sure that we have the hands to pass the torch to, so it can be carried into the future. Appropriate board composition is important not only for the operation of the entire team, but for individual well-being of each of the members. Group of directors ought to be filed with members, whose mutual interaction has a beneficial and positive nature. The elected individuals ought to be strongly identified with the aluminium industry and be committed to maintaining ICSOBA credibility and accountability on the international scale. The renewed board would be expected to forge a strong bond and trust with present members and push ICSOBA's legacy to the next level.

Membership

ICSOBA is a well-recognized international not-for-profit association of members with the vision of being the "Technology Conference of the Aluminium Industry, for the Aluminium Industry". ICSOBA Mission consists in:

- Promoting the exchange of ideas and know-how from different fields of research related to bauxite exploration and mining, and alumina and aluminium production.
- Organizing yearly Technology Conference with a scope of covering upstream aluminium activities from bauxite to liquid metal. Annual events represent a platform to advance the interests of our society as ICSOBA is the industry ally.
- Organizing this event in such a way that it encourages companies to send their employees, universities and other R&D organizations to send their professors and students, consultants, suppliers and individuals to attend and contribute.

ICSOBA members are active in different fields and specializations, and they work within different social and economic frameworks, but there is one thing they have in common: they share the same conviction of the strategic role of aluminium in the present stage of world development.

Authors

- There are no fees or charges for manuscript processing and/or publishing papers in TRAVAUX. Templates for abstracts, papers and presentations, as well as the submission procedures are clearly stated on the website. Authors must comply with the Templates.
- Each paper is accompanied by a presentation which must be presented at the conference by one of the authors or in exceptional case by another delegated person.
- All abstracts, papers and presentations are reviewed in order to guarantee high quality and the authors should follow corrections and instructions from the reviewers.
- Citations of the text or figures should be referenced.
- Financial support and permission to publish can be acknowledged.
- Acknowledgment can be given to contributors to the paper or research who are not the authors.
- Authors should make sure that the published material has been reviewed and authorized by the companies or organizations contributing to the technical material or who gave financial support for the published research.
- If some of the content of a paper has been already published before, at least one third of material must be new for an ICSOBA paper; otherwise the paper will be refused.

Review Process

- Subject Organizers are responsible for the review process in their subject. The Program Director is responsible for the review of Keynote papers. They can be assisted by nominated reviewers.
- The review process assures high technical quality of papers and presentations, as well as uniform formatting, defined in Templates.
- Reviewers should avoid conflict of interest with authors.
- Reviewers should point out relevant published work which is not cited in the paper.
- Reviewers should keep the papers confidential until they are published.

Publication Ethics

Editors shall identify and refuse the publication of papers which are strictly commercial.

Editors shall identify and refuse the publication of papers that contain unsubstantiated, conflicting or misleading results and claims.

Editors shall accept a corrected version of a paper by the authors and make it available in appropriate electronic version.

Copyright and Access

ICSOBA papers are not copyrighted and can be freely reproduced and distributed publicly. The papers from recent years are available on ICSOBA website to which internet browsers also give access.

Archiving

ICSOBA has archived all the past TRAVAUX which can be made available on request to ICSOBA.

Report on the 2nd International Bauxite Residue Valorization and Best Practices Conference

The 2nd International Bauxite Residue Valorization and Best Practices Conference (further on BR-2018 Conference) was held between 7-10 May 2018 in Athens, Greece. This conference was a continuation of the BR-2015 Conference that took place in Leuven, Belgium (5 to 7 October 2015), which was unique in its kind since it gathered professionals from all over the world who worked on various aspects of the valorization of bauxite residue (traditionally called "red mud").

The conference was organized in seven thematic research and development areas, aiming at a zero-waste utilization of bauxite residue:

- From bauxite to a modified bauxite residue
- Neutralization, revegetation and beyond
- Integrated, near zero waste processes
- Novel Applications
- Recovery of Fe, Al, Ti
- Cement, concrete and inorganic polymers
- Recovery of critical elements

Altogether 61 publications were submitted (4 keynote lectures, 38 oral presentations and 19 posters were held accompanied by short oral summaries). The number of participants was about 150. The Keynote lectures were:
