Foreword

Dear ICSOBA Members,

At the time of printing this foreword, we are only three months ahead of our 37th international conference which will be held in the Business Center "Siberia" in Krasnoyarsk, Russia, from 16th to the 20th of September with RUSAL as Host Sponsor. This year conference is in cooperation with the 25th "Aluminium of Siberia" conference within the XI International Congress and Exhibition "Non-Ferrous Metals and Minerals. The program organizers received close to one hundred abstracts. As you understand, complying with abstract and full paper deadlines is paramount to ensure quality review by the Technical Committee. However, as a tradition with ICSOBA, we will make our best efforts to integrate late abstracts.

Since the Belem conference our aluminium landscape again faced significant changes with a continuation of the downward trend of the LME which withdraw from around 2000 \$/t to 1750 \$/t. In the same time, the alumina market settled at about 350 \$/t after a year of very high volatility consecutive to Alunorte production cuts and Alcoa Western Australia strikes. Early 2019 saw the lift of US sanctions against RUSAL and announcement of the return of Alunorte to full production. Also, in the Middle East, the Al Taweelah EGA refinery was started. Finally, Guinea confirmed its first rank in seaborne bauxite market.

Alongside those events and announcements, Industry 4.0 concept is making further progress and we are proud to have organized and chaired a session during 2019 Future Aluminium Forum in Warsaw, Poland. The event is a testimony of ICSOBA engagement to support development trends of automation and digitalisation in Aluminium Industry. Presentations given during this session were made available to ICSOBA Corporate Members.

This year ICSOBA is returning to Russia, a country with a long history of aluminium industries and technology development, and it will be the perfect forum to learn and debate those issues.

With probably the highest number of papers on bauxite, bauxite residue and alumina refinery amongst international conferences, ICSOBA is keen to contribute to the development and the dissemination of new solutions to reduce our industry environmental footprint.

Smelting and Carbon sessions will also give opportunities to listen to latest innovation in the industry and plenary keynote session will stage renowned speakers including representatives from our host company, RUSAL, but also to several Indian and Chinese industry leaders, as well as market and general presentation from CRU.

As you know, ICSOBA vision is to be The Technology Conference of the Aluminium Industry, for the Aluminium Industry. ICSOBA is a truly international organization which is reflected in its Board composition integrating a fully diversified association representatives, both in terms of Companies and Geography.

ICSOBA is one of the rare organizations, if not the only, bringing its conference on the home turf of its members having recently visited Brazil, Canada, China, Germany, India, Russia and UAE, thus providing unique opportunity for local contributors to take on the stage and share their success or their challenges with technical, operation and management colleagues.



ICSOBA is also and mainly an organization belonging to its members. Krasnoyarsk general assembly will provide an opportunity for the Board to report on the work done since the last conference and for the members to express their views and votes.

Participating in an ICSOBA event is not only rewarding for a delegate but more importantly it is also of high return for delegate's companies through the know-how they bring back home from these few days.

As of this 37th ICSOBA conference, I would like to extend my best wishes, on behalf of the ICSOBA Directors, to all of you for an enjoyable and successful conference in Krasnoyarsk.

RUSAL and Russia Aluminium Industry

Birth of Russian aluminium industry took place in 1932 with the creation of Volkhov aluminium smelter near Leningrad. Since that time, over 10 alumina refineries and 15 aluminium smelters have been built in USSR / CIS countries using domestic and imported raw materials. The unique feature of Russian aluminium industry is that the absence of high-quality local bauxites and strategic reasons led to creation of unique technologies to process domestic low-grade bauxites and non-bauxitic raw materials such as nepheline, clays and alunite. The nepheline technology is waste-free, allowing converting all ore components to useful products like soda ash and cement. There are also developments to extract scandium oxide, gallium and vanadium pentoxide while processing bauxites.

Russian Aluminium Company, RUSAL is now a leading global aluminium producer of primary aluminium and alloys. In 2017, UC RUSAL accounted for approximately 5.8 % of global production of aluminium and 6.3 % of alumina. UC RUSAL employs 61 000 people in 20 countries across 5 continents. The Company's production chain is vertically integrated and begins at the bauxite and nepheline ore mines, then moves through the alumina refineries, the aluminium smelters and casting houses, the foil mills and ends at a packaging and wheel production centers.

One of the Company's main priorities is becoming a global leader in terms of aluminium production efficiency whilst still maintaining one of the lowest carbon footprints in the industry. To achieve this, UC RUSAL is investing in in-house R&D and is implementing RA-550 smelting technology and revolutionary inert anode technology, new technologies of alumina production from clay using hydrochloric acid and bauxite residue valorization. The Company is also developing new products, including new types of alloys and is upgrading its production facilities.

Visa Support

How to obtain a Russian business visa

To obtain **the business visa** to Russia you will need to receive the official invitation from the company-organizer (Light Metals Ltd.), which is issued by the Department of the Federal Migration Service of Russia. Light Metals Company will file a petition to the Department on your behalf. After that the Federal Migration Service will start preparing the invitation. This procedure takes **22 working days**, because the documents should be checked by the Ministry of Foreign Affairs of Russia.

When the invitation is ready the organizing committee will send you the electronic version of it by e-mail. Then you should print it and apply for a business visa to the Embassy of Russia in your country.

Take into account, that visa support costs 35 USD per participant to cover visa fee and invitation letters to the Russian federal migration service.

Please note that the official invitation does not guarantee you will be granted a visa. Organizing committee cannot send the letter to an embassy or consulate for you nor can we contact the embassy or consulate on your behalf. It is the sole responsibility of the participant to obtain the necessary paperwork for entry to Russia.

ICSOBA Financial Situation

ICSOBA fiscal year with Revenue Quebec and Revenue Canada is from 1 January to 31 December. Management of ICSOBA is responsible for the preparation of these financial statements in accordance with Canadian accounting standards for not-for-profit organizations. Continuing our dedication to transparency ICSOBA finances are audited. Since 2013 a public accountants' office of Gariépy & Bussière CPA INC is requested to carry out the annual task. Gariépy & Bussière have reviewed the accompanying financial statements of ICSOBA that comprise the balance sheet as at December 31, 2018, and the statements of income, changes in net assets and cash flows for the year then ended, and a summary of significant accounting policies and other explanatory information.

Almost all liabilities of 2018 correspond to deferred Corporate Membership paid for several years to come. In the 2018 financial statements of the auditors we read: "Based on our review, nothing has come to our attention that causes us to believe that the financial statements do not present fairly, in all material respects, the financial position of ICSOBA as at December 31, 2018, and the results of its operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations."

As the financial statements reveal the excess of revenues over expenses was CAD28,704 last year, compared to losses in some of the previous years (2013, 2014). This was chiefly possible due to better than expected delegates participation from Brazil. Also, no services were hired to do local organization tasks as all contributions came from ICSOBA and HYDRO staff. The support from sponsors and exhibitors (\$106,116) was better than last year.

Following the financial review, the tax declarations were filed with Revenue Quebec and Revenue Canada for 2017. Confirmations have already been obtained that ICSOBA does not have taxes to pay and retains its not-for-profit status.

ICSOBA primary revenue leaders are the events and sponsors. We would like to take this opportunity to thank sponsors and exhibitors for your invaluable support. It is such a privilege to be able to count on a strong and devoted community. Your support makes a real difference. As a not-for-profit, ICSOBA focuses on using all resources to advance the association's mission. The available funds belong to the association and are meant for the development and promotion of ICSOBA and future events. Some money reserve is necessary for rainy days and to continue uninterrupted operations and monetary advances. Present ICSOBA monetary reserve should help to ensure continuity of ICSOBA.

It is fair to acknowledge that it is not possible to have ICSOBA management working very hard and very long hours without some compensation. Also, several volunteers provide significant amounts of time to the activities of the organization. Because of the difficulty in assigning values for such services, the value of donated time is not reflected in the financial statement. At the same time, we admit that any compensation needs to be transparent.

Some changes to compensations of ICSOBA management and organizing staff were proposed. For example, the Board of Directors has resolved to wave the conference registration fee to assist active organizers and help them participate in the events.

ICSOBA Membership

ICSOBA is a well-recognized international not-for-profit association of members with the vision of being the "Technology Conference of the Aluminium Industry, for the Aluminium Industry".

ICSOBA members are active in different fields and specializations, and they work within different social and economic frameworks, but there is one thing they have in common: they share the same conviction of the strategic role of aluminium in the present stage of world development.

There are two (2) classes of members in the association namely Individual Members and Corporate Members. Membership is typically renewed every year (however Corporate Members are encouraged to subscribe multiyear membership) with a cycle time starting on the first day of the yearly conference and ending on the eve of the first day of following year conference.

Authors

- There are no fees or charges for manuscript processing and/or publishing papers in TRAVAUX. Templates for abstracts, papers and presentations, as well as the submission procedures are clearly stated on the website. Authors must comply with the Templates
- Each paper is accompanied by a presentation which must be presented at the conference by one of the authors or in exceptional case by another delegated person
- All abstracts, papers and presentations are reviewed in order to guarantee high quality and the authors should follow corrections and instructions from the reviewers
- Citations of the text or figures should be referenced
- Financial support and permission to publish can be acknowledged
- Acknowledgment can be given to contributors to the paper or research who are not the authors
- Authors should make sure that the published material has been reviewed and authorized by the companies or organizations contributing to the technical material or who gave financial support for the published research
- If some of the content of a paper has been already published before, most of the material must be new for an ICSOBA paper; otherwise the paper will be refused.

Review Process

• Subject Organizers are responsible for the review process in their subject. They can be assisted by nominated reviewers. The Program Director is responsible for the review of Keynote papers



- The review process assures high technical quality of papers and presentations, as well as uniform formatting, defined in Templates
- Reviewers should avoid conflict of interest with authors
- Reviewers should point out relevant published work which is not cited in the paper
- Reviewers should keep the papers confidential until they are published.
